**ADDENDUM TO ARTICLES OF INCORPORATION
OF
VCA BOOSTER CLUB**

**ARTICLE 7
NAME**

The name of this non-profit corporation shall be VCA BOOSTER CLUB (hereinafter, the "Corporation"). The Corporation shall be formed pursuant to Chapter 82 of the Nevada Revised Statutes.

**ARTICLE 8
PURPOSE**

The purpose of this Corporation shall be to provide support for all student athletes of Vegas Cheer Authority and to promote and support all-star cheerleading in the State of Nevada. All funds, whether income or principal, and whether acquired by gift or contribution or otherwise, shall be devoted and allocated to said purposes.

This non-profit corporation is organized exclusively for charitable, religious, educational, and scientific purposes as specified in Section 501(c)(3) of the Internal Revenue Code, including for such purposes, the making of distributions to organizations that qualify as exempt organization under Section 501(c)(3) if the Internal Revenue Code, or the corresponding section of any future federal tax code.

**ARTICLE 9
EXEMPTION REQUIREMENTS**

At all times, the following provisions shall operate as conditions restricting the operations and activities of the Corporation:

1. No part of the net earnings of the Corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purpose set forth in Article 8, above.
2. No substantial part of the activities of the Corporation shall constitute the carrying on of propaganda or otherwise attempting to influence legislation, or any initiative or referendum before the public, and the Corporation shall not participate in, or intervene in (including by publication or distribution of statements), any political campaign on behalf of, or in opposition to, any candidate for public office.
3. Notwithstanding any other provision of these articles, the Corporation shall not carry on any other activities not permitted to be carried on by: (i) a corporation exempt

from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (ii) a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

ARTICLE 10
MEMBERSHIP AND BOARD OF DIRECTORS

This Corporation shall have members and is a non-stock corporation. The Corporation shall not practice discrimination on the basis of race, color, sex, age, national or ethnic origin, or creed in any of its activities, or violate the terms of any applicable federal or state law pertaining to discrimination. The eligibility, rights and obligations of the members will be determined by the Corporation's Bylaws.

The management of the affairs of the Corporation shall be vested in a board of directors, as defined by the Corporation's Bylaws. No director shall have any right, title, or interest in or to any property of the Corporation. The number of directors constituting the initial board of directors is nine (9); their names and addresses are as follows:

No member, officer, or director of this corporation shall be personally liable for the debts or obligations of the Corporation of any nature whatsoever, nor shall any of the property of the

members, officers, or directors be subject to the payment of the debts or obligations of the Corporation.

ARTICLE 12
DURATION AND DISSOLUTION

The duration of the corporate existence shall be perpetual until dissolution. Upon the dissolution of the Corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the Corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
